Ten or more taxpayers or one (1) taxpayer that owns property that represents at least ten percent (10%) of the taxable assessed valuation in the political subdivision affected by the county board of tax adjustment's action on a political subdivision's budget may initiate an appeal by filing an objecting petition with the County Auditor to such budgets within ten days from the date of publication of this notice. All appeals shall be in writing addressed to the Department of Local Government Finance naming specifically the items in the budgets and the tax rates, which are objected to, and shall be filed with the County Auditor. The Auditor shall forward the statement, with the budget to the Department of Local Government Finance for consideration. This notice is given in compliance with Acts of 1937, Chapter 119, as amended by Acts of 1947, Chapter 41, and the rights of taxpayers and the manner of filing objections are set forth herein.
