

Citizen of the Year Award Guidelines

The Huntsville Item

Nomination Deadline: 5:00 p.m. January 19, 2009

The Citizen of the Year Award recognizes individuals of Walker County who have made significant contributions to the city or county.

Guidelines:

1. One individual or couple will be recognized each year.
 2. Nominees will be judged according to their contributions toward the advancement of the community with **particular emphasis on the last twelve months**. Individuals who have made significant contributions to the city or county or who have made significant contributions to society, and thus, have brought honor and distinction to the city or county are eligible.
 3. Recipients must attend the award ceremony. This year the banquet will be held on: February 19, 2009.
 3. Current employees and spouses of the Huntsville Item are not eligible for this award.
 4. Current Readers Advisory Board and spouses are not eligible for this award.
 5. Any individual or group may submit a nomination to the committee. A nomination is good for only one year.
 6. Prior nomination does not preclude a future nomination.
 7. Must be a resident of Walker County.
 8. Complete the nomination form, attach supporting documents and submit the nomination to the Huntsville Item, **attention Citizen of the Year Committee**.
