## CHARITY GAMING

Legalized gambling is not always held on a casino floor. The state tightly regulates charity gaming operations and the millions it brings in for organizations.

### ► CLARK COUNTY Bingo/Pull Tabs Gross Amounts:

- 2007: \$12 million
- 2006: \$12.3 million
- 2005: \$12.2 million
- 2004: \$14.3 million
- 2003: \$13.2 million

Of the \$12 million raised, net proceeds were about \$893,468. Of those proceeds, about \$303,178 was given to charities in 2007.

### 2007 Amounts raised by bingo/pull tabs:

- **Fraternal Order of Police, No. 100, Jeffersonville: \$3.3 million.** After expenses, net proceeds were \$141,294, a 4 percent profit. Of that, the organization gave about \$74,488 to charity. Amount retained: \$69,472. Total undistributed: \$11,019.
- **Knights of Columbus No. 1348, Jeffersonville: \$1.7 million.** Net proceeds, \$46,992 a 3 percent profit. About \$46,992 went to charity. Amount retained: \$0. Total undistributed: \$33.
